NOTIFICATION: 2019-2020 Seasonal measures for Brown Marmorated stink bug (BMSB)

Dear Valued Customer,

The Department of Agriculture has finalised the BMSB seasonal measures for the 2019-2020.

Measures are effective for ALL Sea freight shipments exported on or after the 1st of September 2019 and that arrive in Australian territory by 31 May 2020 (inclusive).

Measure apply to goods manufactured and/or originating in any of the below countries:

Are your goods classified as HIGH RISK or RISK?

HIGH RISK goods require:

• <u>Mandatory offshore treatment</u> for Open Top, Flat Rack and Break bulk shipments

 Mandatory treatment either offshore OR in Australia for LCL/FAK, FCL & FCX shipments

• Increased onshore intervention through random inspection.

All LCL consignments shipped with Rohlig from BMSB countries regardless of RISK category will be treated. This is in order to protect the integrity of the Rohlig LCL programme and mitigate the risk of delays and additional costs.

Throughout the season Department of Agriculture will continue to review these measures based on detections of BMSB and the risk pathways and make any necessary adjustments.
